## 1. INTRODUCTION

### 1.1. Satya Foundation

Satya Foundation, a public charitable trust registered under the Indian Trusts Act 1882 (also registered under section 12AA and 80G of the Income Tax Act), is an organisation committed towards rural resurgence and promoting Vedic and ancient sciences. It is promoted, governed and patronised by eminent personalities with exceptional social credentials that have come together to work for a resurgent India to make it a truly global powerhouse, further propelling India's growth story. The Foundation strives to create an environment where the Government, public undertakings, corporates, NGOs and society collaborate for a common, greater public good.

## 2. Scope of Work and Deliverables for the Vendor

### 2.1. Scope of Work

The scope of work covered in this tender shall be as per the BOQ, specifications, drawings, instructions, orders issued to the vendor from time to time during the execution of work. The total area where the work needs to be undertaken is 3919 ft approx. Address of the Site: Kuteti Uttarkashi

### 2.2. Deliverables and Timelines

1. **The Contract Period:** The Contract period shall be reckoned from the seventh (7<sup>th</sup>) day of issue of Work Order. The completion of the contract shall be date of issue of completion certificate. The commencement date for Defect Liability Period is the completion of Contract period.
2. **The Construction Period:** The Construction Period shall be **05 Months** from the commencement date. The completion date shall be the date of completion of the works at the end of the construction period including any extensions granted and taking care of snag list.

## 4. Bid Evaluation and Selection Process

Overall evaluation of the bids will be done in two stages namely Technical and Financial evaluation.

### 4.1. Proposal Submission Guidelines

1 vendors shall mark the below title in bold on all submissions and their company name with address clearly mentioned at the bottom right corner of the cover. BID Submission for RFP: "**The Construction of Dinning Hall, Yoga Hall, store & Parking in Swami Vedananda Ved Vidyalaya**". Also mention on top of the sealed envelope, the nature of the document "**Technical Proposal**" or "**Financial Proposal**".

#### 4.1.1 Technical Proposal

The Technical Proposal (**one hard copy**) shall be submitted with the following:

1. Pre-Qualification Documents (as per the Pre-Qualification Criteria clause)
  - i. Form - 1
  - ii. Form - 2

#### 4.1.2 Financial Proposal

The Proposal should be signed by the authorized signatory and submitted in a sealed envelope, only as a hardcopy, separate from the Technical proposal. Softcopies are not permissible. The Proposal must adhere to the following guidelines:

1. The Vendors should submit the proposal as per the format given in Annexure - A  
Taxes would be additional and as per applicable statutory norms.

## 4.2 General Terms and Conditions

The Vendor for this engagement would be selected through a competitive bid process, the details of which are provided below:

- a. The Satya Foundation reserves to itself the authority to reject any or all the tenders received without assigning any reason. The acceptance of a tender shall be effective w.e.f. the date on which the telegram/ letter of intent of acceptance of the tender is put in the communication by the Satya Foundation.
- b. **MOBILIZATION OF MEN, MATERIALS AND MACHINERY:** All expenses towards mobilization at site and de-mobilization including bringing in equipment, work force, materials, dismantling the equipment, clearing the site etc. shall be deemed to be included in price quoted and no separate payment on account of such expenses shall be entertained.
- c. The rates quoted by the tenderer shall be firm and fixed for the entire period of completion and till handing over of the work. No revision to rates or any escalation shall be allowed on account of any increase in price of materials, labour, POL and overheads etc or any other statutory increase during the entire contract period.

- d. No claim on account of any price variation / Escalation on whatsoever ground shall be entertained at any stage of works. All rate as per BOQ quoted by contractor shall be firm and fixed for entire contract period as well as extended period for completion of the works. No escalation price variation clause shall be applicable on this contract.
- e. **Employment of Personnel:** The contractor shall employ only Indian Nationals as his representatives, servants and workmen after verifying their antecedents and loyalty. He shall ensure that no personal of doubtful antecedents and any other nationality in any way is associated with the works. Contractor will need to submit an undertaking to this effect before start of works. Satya Foundation shall have full power and without giving any reason to the contractor, to immediately remove any representative , agent, servant and workmen or employee on account of misconduct negligence or incompetence or whose continued employment may in their opinion be undesirable. The contractor shall not be allowed any compensation on this account.
- f. **TECHNICAL STAFF FOR WORK:** The contractor shall employ at his own cost the adequate number of technical and other staff during the execution of this work depending upon the requirement of work. The contractor shall not be entitled for any extra payment in this regard. The technical staff should be available at site, whenever required by Satya Foundation for discussion and to take instructions.
- g. **WORK ON SUNDAYS, HOLIDAYS AND DURING NIGHT:** For carryingout work on Sunday and holidays or during night, the contractor will approach the Satya Foundation Authorised Person or his representative at least two days in advance and obtain his permission. The contractor shall have no claim on his account whatsoever. If work demand, the contractor shall make arrangement to carry out the work on Sundays, Holidays and in two, Three shifts with the approval of Satya Foundation Authorised Person at no extra cost to Satya Foundation.
- h. **Rates to be Firm:** The rates quoted by the tenderer shall be firm and fixed for the entire period of completion and till handing over of the work. No revision to rates or any escalation shall be allowed on account of any increase in price of materials, labour, POL and overheads etc or any other statutory increase during the entire contract period.
- i. **NO IDLE CHARGES TOWARDS LABOUR:** No idle charges or compensation shall be paid for idling of the contractor's labour, staff or P&M etc. on any ground or due to any reason whatsoever. Satya Foundation will not entertain any claim in the respect.
- j. **WORK TO BE EXECUTED IN ACCORDANCE WITH SPECIFICATIONS, DRAWINGS, ORDERS ETC.:** The contractor shall execute the whole and every part of the work in the most substantial and workman like manner both as regard materials and otherwise in every respect in strict accordance with the specification. The contractor shall also conform exactly, fully and faithfully to the design, drawings and instructions issued in respect to the work assigned by the Satya Foundation Authorised Person. The contractor shall comply with the provisions of the contract and execute the works with care and diligence and maintain the works and provide all labour and materials, tool and plants including for measurement and supervision of all works, structural plans and other things of temporary or permanent nature required for such execution and maintenance in so far as the necessity for providing these is specified or is reasonable inferred from the contract. The contractors shall take full responsibility for adequacy, suitability and safety of all the works
- k. **Schedule of Rates:** The quantities shown against the various items of work are only approximate quantities which may vary as per the actual requirement / measurement at site.
- l. **Materials and Samples:** The materials / products used on the work shall be of approved make/ brands out of list of approved makes given in the tender document. The contractor shall submit samples/ specimens of approved makes of materials / products to the Satya Foundation Authorised Person for prior approval. In exceptional circumstances Satya Foundation Authorised Person may allow alternate equivalent makes / brands of products / materials at his sole discretion. The final choice of brand/ make shall remain with the Satya Foundation Authorised Person, whose decision in the matter shall be final and binding and

nothing extra on this account shall be payable to the contractor.

- m. **Warranty:** The manufacturer warranty of all the items should be transferred to Satya Foundation as a part of the handover of the site.
- n. Precautions to avoid any nuisance to the neighbourhood / surrounding. All the necessary precautions will need to be taken during the implementation of the project (either during day or night), to avoid any nuisance or any harm causing to the neighbourhood/surrounding areas of proposed construction site. No complaint should arise by the neighbourhood/occupiers of other office in the building, during the development work by contractor or any of the persons directly or indirectly related to the site work. In case of any such conditions the contractor shall be fully responsible for the consequences & settlement.
- o. **Contractor Liable For Damage Done and For Imperfections:** If the Contractor or his work people or servants shall break, deface, injure or destroy any part of a building in which they may be working or any building, road, fence, enclosure, or cultivated ground, contiguous to the premises on which the work or any part of it is being executed, or if any damage shall happen to the work. If any imperfection becomes apparent while the work is in progress, , or the contractor shall within a period specified by Satya Foundation after a Certificate, final or otherwise of its completion (given by the Satya Foundation Authorised Person or Tendering Authority), shall cause the same to be made good by other workmen and deduct the expense (of which the certificate of the Satya Foundation Authorised Person or Tendering Authority shall be final) from any sums may be then, or at any time, thereafter that may become due to the Contractor, or from his performance security, or the proceeds of sale thereof, or of a sufficient portion thereof.
- p. **Withdrawal of Work from the Contractor:** If the Tendering Authority shall at any time and for any reasons, whatever, including inability to maintain pro rata progress, think any portion of the work should not be executed or should be withdrawn from the contractor, he may by notice in writing to that effect, require the Contractor not to execute the portion of the work specified in the notice, or may withdraw from the Contractor the portion of work, so specified, and the Contractor shall not be entitled to any compensation, by reason of such portion of work having been withdrawn from him. The Satya Foundation Authorised Person or Tendering Authority may supplement the work by engaging another agency to execute such portion of the work at the cost of the original contractor without prejudice to his rights. He shall also be competent to levy penalty for delay in progress. The recovery of excess cost shall be made good from next available 3 running bill or any other claim and shall not be deferred.
- q. **Protect Works:** The contractor shall arrange to protect, at his own cost, in an adequate manner all stone work and other works , requiring protection and to maintain such protection, as long as work is in progress. He shall remove and replace this protection as required by the Satya Foundation Authorised Person or Tendering Authority, from time to time, any damage to the work, so protected no matter how it may be caused. Shall be made good by the Contractor free of cost. All template , forms, moulds, centering, false ceiling works and models, which in the opinion of the Satya Foundation Authorised Person or Tendering Authority, are necessary for the proper and workman like execution of the work, shall be provided by the Contractor free of cost.
- r. **Fair Wage Clause:** The contractor shall pay less than fair wages/minimum wages to labourers engaged by him on the work as revised from time to time by the Government but the shall not be liable to pay anything extra.
- s. **Safety of Workers:** Ensuring safety of workers at time of construction shall be the responsibility of the bidder. Satya Foundation has no obligation or responsibility towards any individual in any such case or situations. The bidder must have and maintain valid and keep in force insurance policies accidents, public liability, professional indemnity, worker's compensation required by law. The bidder shall provide personal protective equipment like helmet, face shield, gloves, safety shoes, etc., of standard make acceptable, to all the employees at their cost.

- t. **FORCE MAJEURE:** Any delay in or failure of the performance of either party hereto shall not constitute default hereunder to give rise to any claims for damages, if any to the Extent such delay or failure of performance is caused by occurrences such as acts of God or the public enemy , expropriation, compliance with any order or request of Government authorities, acts of war, rebellions, sabotage fire, floods, illegal strikes, or riots (otherwise than among the contractors employees). Only extension of time shall be considered for Force Majeure conditions as accepted by Satya Foundation. No adjustment in contract price shall be allowed for reasons of force majeure.
- u. The contract will be awarded to the Vendor whose proposal conforms to the terms of the RFP and is, in the opinion of Satya Foundation, the most advantageous and represents the best value of the assignment, price and other factors considered. Satya Foundation reserves the right to negotiate with the most competitive Vendor if required.
- v. **COVID-19 Guidelines:** The bidder needs to ensure that all the personnel adhere to WHO and MHA COVID- 19 safety protocols at all the time during the construction period.
- w. **Liquidated Damages:** The work must be completed as stipulated in the acceptance of the tender should be deemed to be the essence of the contract and delivery must be completed no later than the dates specified therein. Extension will not be given except in exceptional circumstances. However, if the work is completed after expiry of the contracted completion period without prior concurrence of Satya Foundation, such delivery will not deprive the purchaser of his right to recover liquidated damages.
- x. **Confidentiality:** The bidder(s) must not divulge any confidential information and ensure that reasonable steps are taken to provide for the safe custody of any and confidential information in its possession and to prevent unauthorized access thereto or use thereof. The shortlisted bidder(s) must not, without the prior written consent of Satya Foundation, disclose any confidential information of Satya Foundation or any government department or relating to any ministry or any other party. In giving written consent to the disclosure of confidential information, Satya Foundation may impose such conditions as it thinks fit, and the bidder must comply with these conditions. Confidentiality clause shall survive for a period of one year after the termination of contract or contract expiry period.
- y. **Payment Milestones:**
  - Advance Payment:** 25% of the total Job Value shall be released with confirmed work order
  - First Running Bill:** 25% of the total job value shall be released on Completion of brick and slab work of Dinning Hall.
  - Second Running Bill:** 25% of the total job value shall be released on Completion of finishing work of Dinning hall and foundation work of parking area
  - Third Running Bill:** 25% of the total job value on completion of the job
- z. **Penalty:** Penalty may be imposed on non-performance/ violation of any of the terms and conditions mentioned in this work order. The quantum of such penalty shall be as decided by the committee of officials (constituted by Satya Foundation). The following shall be the treatment in case of damages and delays:
  - a. Any damage to the building or to any equipment which might result during the repair shall be repaired by the Contractor/ Service Provider.
  - b. If the job is not completed within the stipulated time penalty amount @ 1% (of the contract value) per day will be applicable on the contractor.
